

PP4-NIMRD G.Antipa Constanta has been involved in the project activities and work packages along the first year of the project MARSPLAN BS II. The implementation of the project "Cross border Maritime Spatial Planning for Black Sea Romania and Bulgaria" (MARSPLAN –BS II)" started in 01.07.2019. Till present the contribution of the NIMRD G.Antipa Constanta answered to the project's specific objectives planned to be developed and done in the first year period:

- Contribution for supporting the implementation of MSP Directive in the Black-Sea Basin: a)
 Assuring marine spatial data collection and inventories for spatial analyses (Annex 1,2); b)
 Supporting the Specification Tender for auction to elaborate the national Maritime Spatial Plan; c)
 Identification spatial data and data providers to support the addresses preparing to be sent by the
 MPWDA to the different ministries and companies, aiming MSP Database consolidation and maps
 elaboration (Annex 3).
- Contribution for supporting the continuity in the cross-border MSP process for the Black Sea Basin: a) Collaborating with all Romanian partners focused in the objectives enhancement, mainly with the MSP Authority of Romania(Annex 4); b) Collaborating with the Bulgarian partners, mainly with the objectives and deliverables responsible and the contributors for the studies 1.1.1 and 1.1.2, aiming knowledge integration (Annex 1,2); c) supporting the link between authorities, experts, professional groups of the coastal and marine areas (Annex 5).
- Contribution for supporting capacity building and Competent Authorities in the MSP implementation: a) Listing the main stakeholders' network of experts, Annex 5, b) Communicating with the MSP Authority in Romania to share experience and consolidate MSP Centre and GIS database of MPWDA (Annex 6).
- Contribution to the elaboration of the maritime spatial plans in Romania, based on the results of the first MARSPLAN-BS Project: preparing studies and deliverables of the MARSPLAN BS I and II, as support to the MSP plans elaboration and MSP process implementation (MSP legislation, methodology, practices, thematic and integrated maps, etc.) (First Progress Report).
- Contribution for the MSP Multi-Use (MU) and Land-Sea Interactions (LSI) concepts, implementation for a common strategy elaboration in the cross-border area of Bulgaria and Romania inventory of specifical documentary, practices, interviews, consultancy (Annex 7).
- Contributions to the stakeholder participation in the design of national and cross-border MSP process: a) due to the long-term institutional experience in working with different maritime professional groups, b) due to organization and participation to the stakeholders meetings; c) supporting a new approach on on-line meetings between specialists, social and professional groups (Annex 8).
- Information Sharing for the best available data and communicate knowledge on MSP for the Black Sea Basin, contribution to the project results sharing and presentation with different occasions, events (Annex 9) in a traditional network of expertise at regional and European level, including EU-MSP Platform.

Concluding, during July 2019 to June 2020, NIMRD GA contributions to the main objectives of the MARSPLAN BS II project implementation, has materialized, in:

- Participation to the Project's meetings, Kick of meeting, Steering Committees, Project Opening Conference, Advisory Boards and Working Meetings with Romanian teams (Annex 8);
- Main deliverables/studies elaboration, NIMRD having the responsibility of Studies 1.1.1 and 1.1.2 (Annexes 1,2), under the coordination of PP3-NRCD: a) Collecting partners contributions; b) Continuing the integration of information, maps and design, c) Integrating Romanian and Bulgarian parts of knowledge for studies, d) Processing information for spatial analyses;

- Contributing for other objectives, activities, products, results, LSI Interaction, MU, (Annex 7), data sharing; Preparing documents and questionnaires for on-line stakeholders' meetings, field expeditions being postponed because of 2020 unexpected circumstances (Annex 7);
- Participation and/or organization of different national events; Participation to international MSP events (Annex 9);
- Publication of scientific articles, posters (Annex 10).

Work package 1. Development of Maritime Spatial Plans

Activity 1.1 Support the work of national competent authorities in charge of developing and implementing maritime spatial plans

Sub-activity 1.1.1. Synthesis report on maritime uses (deadline 01.02.2020) started to be prepared by NIMRD from second project month, with both Bulgarian and Romanian partners contributions. For the Romanian part of the study, NIMRD took into account the Romanian MSP legislation, Romanian MSP authority recommendations and the stage of MSP Directive 89/2014/EU implementation. The report synthesized information and available knowledge for the maritime space of Bulgaria and Romania, based on detailed studies and case studies resulted from the First MARSPLAN-BS Project, stressing the main data which can support the MSP objectives of the project and planning processes in the both countries. (Annex 1). NIMRD contributed to almost all chapters and integrated the Romanian with the Bulgarian parts of studies, reported in the First Progress Report (first 6 month of the project) and installed it on the project site (Sharelink). The variant for publication was ready after all partners checking the last consolidated study.

- Sub-activity 1.1.2. Defining and analysing existing conditions in the maritime space, (Annex 2)_started to be prepared in November 2019, up-dating spatial maritime information.
 - The study is based on examples resulted from the European policies, rules, experience (UNESCO recommendations, Baltic and Mediterranean Seas practices), EU-MSP Platform divers cases, national statistics, the own partners projects and data (the most important NIMRD studies concerning marine environment status, maritime policy like MSFD implementation -, annual reports and monitoring data. The study 1.1.2 in Romania was coordinated by NIMRD (involved in almost all chapters, excluding those dedicated to governmental issues, tourism domain, part of marine geology chapters, UCH, military areas) in collaboration with GeoEcoMar; MPWDA and UOC had their specifical contributions.
 - NIMRD defined important spatial information on different maritime domains and data sources providers to be prepared and sent the addresses of the MPWDA for the main ministries and companies activating on the marine space, aiming maritime data updating.
 - The Study 1.1.2. (Romanian part) is finalized in its first variant and it is considered "in progress" stage; it can be updated till the end of the project because of reasons explained above. The Bulgaria part is added at the end, to be integrated before the deadline. Both countries respected the summary and size established in common, for the study chapters. Added to the Study 1.1.2, NIMRD waits the

necessary geographical coordinates or layers for the planned/nominated (ten) maps, to be delivered by the GIS responsible of the MARSPLAN BS II Project.

Sub-activity 1.1.3. Defining and analysing future conditions was discussed during the interdisciplinary workshop organized by the Bulgarian Naval Academy, in Varna, in 12 December 2019. The content of this study is focused on future conditions, prognosis, scenarios, and the necessity for future meetings during its progress stages, till the end of 2020. The first results will be available the next month taking into account the analyses resulted from the present studies (1.1.1, 1.1.2, MU, cases studies, ecosystem and transboundary approach) and future or 'in developing' studies (LSI, MSP Plans elaboration); the interdisciplinary workshops will be helping when or if they will be organised in Constanta or Bucharest till the end of the year.

> Activity 1.2. Elaboration of the Maritime Spatial Plans, had the following aims:

- Sub-activity 1.2.1. Follow-up of the common framework in relation with national Maritime Spatial Plans (MSPs), overcoming the existing gaps. Main support for the Study 1.1.2, have been received after policy notes contents and scope adopted by Bulgarian and Romanian partners (PP1, PP2, PP3) and deliverables received (as valuable supportive document and maps). Work is in progress, because of necessity to be finalized.
- Sub-activity 1.2.2. GIS database update and GIS model design identifying information sources for metadata and data sets, common standards and formats in line with INSPIRE Directive (Annex 6). NIMRD is a contributor to the existing databases of EMODNet, EU MSP European Atlas of the seas, Biodiversity Information System for Europe etc., different national information systems of different authorities and also the main provider for the MARSPLAN BS I Project:
 - spatial data including data format and data studies, sent to MPWDA
 - maps elaborated for the marine space, on some domains and for transboundary area.
- Sub-activity 1.2.3 Maritime Spatial Plans strategies development deadline 01/01/2021; there are defined two aspects: contribution to the national spatial plan development and transboundary plan between Romania and Bulgaria. The work is in progress for both main goals, taking into account the information resulted from the study 1.1.1 and 1.1.2 and the experience of NIMRD as custodian of the Marine Protected Areas, Vama Veche 2 Mai, at the Bulgarian border.

Work package 2. Connecting cross-border to national MSP:

- Activity 2.1. Common strategy for MSP in cross-border area Bulgaria and Romania deadline 30/06/2021 just started.
- Activity 2.2. Encouraging stakeholder cooperation in the cross-border region, leaded to:
 - Establishing a large list of stakeholders, from the whole coastal and transboundary areas. The situation concerning pandemic's restrictions made difficult stakeholders meetings organizations (Annex 5);
 - Stakeholder mapping for Romanian for the border areas has been done.
- Activity 2.3. Integration of Land-Sea Interactions (LSI) in MSP for the cross-border region,
 Documentation and experience have been gained concerning LSI practices, methodology and integration.
 NIMRD is nominated Technical Secretariat for the National Committee of Coastal Zone (CNCZ) in Romania
 leaded by the Ministry of Environment, Waters and Forests (MEWF) and national ICZM reporter for the
 Black Sea Commission. NIMRD elaborated studies related ICZM and MSP, which are support for the LSI.
- Activity 2.4. Addressing the Multi-Use (MU) concept with MSP in the cross-border region.
 Documentation and analyses of MU concept and MUSES Project' study cases have been taking into account, by:
 - Sharing all documents and information with Romanian partners for thoroughgoing study;
 - Establishing the questionnaire and interviews for stakeholders;
 - Collecting significant data in the MPA, tourism and Underwater Cultural Heritage domains to be processed by NIMRD and GeoEcoMar for analyses and DABI model use (first draft), (Annex 7);
 - The Romanian MU study will be integrated under the CCMS coordination adding more consultation results, when conditions will permit.

Work package 3. Management and Coordination, consisted in:

- Activity 3.1. Internal cooperation agreement, NIMRD agreed and signed ICA and sent opinions for the Risk Management Plan, during the project's on going, according to the Action Plan.
- Activity 3.2. Steering Committee of the project, NIMRD participated to the project meetings, organized by the Project Leader,
 - o in 09.10.2019, Sofia, Bulgaria:
 - The Kick-off meeting of the project,
 - The First Steering Committee,
 - The MARSPLAN,s Opening Conference; NIMRD presented the marine environment status in Romanian (Annex 8)
 - The Second Steering Committee, organized by MPWDA was established in Constanta, Romania for the 26.03.2020, together with the thematic workshop dedicated to MSP and Tourism (27.03.2020, UOC), both being postponed because of pandemic restrictions. Second Steering Committee was organized by MPWDA, at least, in 07.06.2020, on-line, as a video conference system.
- Activity 3.3. Advisory Board. NIMRD participated to the Advisory Board meetings in the presence of project partners, MSP Experts from European, Baltic, Mediterranean and Black Sea areas:
 - O The 1st Advisory Board, in 10.10.2010, Sofia, Bulgaria, added to the Opening Conference,
 - The Second Advisory Board-Completed work was organized in 09.07.2020. NIMRD prepared the presentation of the Study 1.1.2 *Defining and Analysing Existing Condition in the maritime space* in Romania, (the first draft), presented on-line by both NIMRD and GeoEcoMar project leaders. A second presentation *ppt* was devoted to the Multi-Uses concept application in Romania; it was presented in similar way (Annex 8).
- Activity 3.4. Financial management. NIMRD established:
 - The team work and its expenses for salaries and travels is included in this report (Chapter 7-Budget). Members List and Notification for the team enlarging are included in the Financial Report (Annex 11). The NIMRD Notifications asked number of experts increasing without any changes in the budget items.
 - o The management, technical and financial responsible were established.
 - Financial Report includes expenses on chapters and time sheets (included in the Interim Report to Chapter 7. Budget). It is elaborated by the financial responsible who is NIMRD economic director (Annex 11).
 - Under the coordination of the Project Leader, the financial forms concerning the stages of the prepayment spending were periodically reported.
- Activity 3.5. Reporting on project progress and results
 - The First Progress Report was prepared and sent in term, presenting the NIMRD activity in the first six months of the project - 01.07.2020-31.12.2020. It was accompanied by a short Technical and Financial Report for the period January-March 2020, at the request of Project Leader.
 - o NIMRD prepared this present institutional Interim Report, too.
 - NIMRD included studies, reports and other materials in the free web space opened by the MRDPW, aiming the improvement of the coordination and communication.
- Activity 3.6. Four (4) Thematic workshops were planned to be done according to the Action Plan:
 - NIMRD participated to the MSP and Shipping routes workshop, organized by the Bulgarian Naval Academy, in Varna, 12.12.2019, (Annex 8); financial documents attached, are included in the financial report (Annex 11).
 - OROmanian Partners planned to organize two thematic workshops (PP7-UOC responsibility), the first one in the field of MSP and Tourism; 27.03.2020 was the first data initiative, but it was postponed because to pandemic restrictions and evolution in the both countries. The second thematic workshop, planned to be organized in Romania by PP7-UOC will be prepared in the field of coastal protection measures against erosion, with significant involvement of NIMRD and GeoEcoMar institutes.

WP 4 Communication and Dissemination

NIMRD maintained a permanent communication between project partners in Romania in the frame of working groups meetings, mainly in Constanta, but also in Bucharest under MSP Authority coordination. NIMRD answered to project leader, MRDPW, requests/messages (Annex 4).

Activity 4.1 Project Conferences

During the studied period, NIMRD participated, to the MARSPLAN Opening Conference, presenting the *Environmental Status in the Black Sea Report* (Annex 8). Documents for participation are attached in the financial report.

- Activity 4.2 Publication. NIMRD published articles in its own research journal, in the field of spatial planning and maritime domains on the both Studies 1.1.1 and 1.1.2 interest: http://www.marine-research-journal.org/index.php/cmrm, Marine Research Journal, 2019, on-line versions (Annex 10).
- Activity 4.3 Website update.
 - The MARSPLAN Website (elaborated by MPWDA, during the Project MARSPLAN BS I) has been updated and it will maintain the activity during the entire project on-going, and during the whole MSP Directive implementation, including NIMRD information and results.
 - NIMRD has the own institutional site, http://www.rmri.ro, which includes a domain dedicated to MSP Projects, http://msp-platform.rmri.ro/marsplan.html, including also MARSPLAN Project. It is a way of MARSPLAN Project spreading information.
 - o NIMRD has also the own institutional *Facebook address*, where there spread all announcements related MARSPLAN events and results.
- Activity 4.4 Promoting MSP in Black Sea basin. Involving MSP in the non-EU countries is a permanent priority of the NIMRD team:
 - NIMRD traditional collaboration and scientifical networking at the national and regional level, including EU-MSP Platform;
 - Promoting the MARSPLAN objectives and planned results with different occasions, meetings and project's thematic workshops: 3 presentations/Activity 3.3; 1/Activity 4.1 (Annex 8)
 - Participation to some events with the project results presentations: 4 events (symposiums, conference). There are 2 regional registrations, postponed because of pandemia, Chapter 3.
 Deliverables (Annex 9)
 - Participation to some national and international events in the field of maritime policies, MSP, Blue Growth, Marine Fisheries policies, sharing experience with experts in the nominated fields, Table 1.
